## THE DETAINED RUSSIAN MAJOR WAS A CHIEF OF MISSILE AND ARTILLERY ARMAMENT FROM RUSSIA.

On July 25, 2015 the employees of the State Border Service of Ukraine on the highway Volnovakha - Donetsk detained a Russian military personnel, who accompanied the cargo of ammunition.

In the back of the car they revealed a large number of boxes of ammunition of different calibers. The load was accompanied by two people.

According to the Security Service of Ukraine, one of them, Vladimir Starkov born in 1978, performs an

active military service in one of the military units of the city Novocherkassk, in the Rostov region. His position is a chief of missile and artillery armament, his personal number is F-549 345.

His wife, Larisa Starkova born in 1978, also works in one of the military units of the Russian Federation. They have two minor children - Eugene (2000) and Nikita (2007).



## MAJOR OF THE RUSSIAN ARMED FORCES TOLD HOW THE RUSSIAN MILITARY MEN APPEAR IN THE DONBASS.

The arrested chief of the rocket and artillery armament from the Russian Federation Vladimir Starkov told how the Russian troops appear in the Donbass.

Military servicemen of the Russian Armed Forces are offered to perform military service in the illegal armed formations "DPR" and "LPR", they promise triple money rewards, take away the documents that may identify them as active military servicemen of the Armed Forces of Russia - a passport, military ID and a token. Soldiers sign a document on a non-disclosure of the fact of military service in Ukraine, they are also instructed about the prohibition of the distinctive signs wearing, that indicate they belong to the Russian Armed Forces. The crossing of the state border is usually carried out at night.



Starkov also said that today the separatists of the illegal groups control 409.3 km of the state border.

**According to Starkov words, on the territory of Ukraine in the ranks of illegal armed groups about 2,000 Russian military personnel fight.**

## THE STATE SECURITY SERVICE OF UKRAINE TOLD HOW THE SEPARATISTS IN THE DONBAS GET THE WEAPONS FROM RUSSIA.

Weapons for the separatists were brought from the warehouses, located in the Russian Federation.

One of the negotiators (on one audio of the telephone conversation between militants intercepted by Security service of Ukraine) says that he receives the weapons and signs the documents in the suburbs of Moscow.

The weapon came in the Russian Federation before the war, and from there moved to us already during the ATO. There is a unique weapon that is not used by the Ukrainian army.

Providing the terrorists with weapon is an example of non-fulfilment of Minsk agreements.

Employees of the Security Service of Ukraine intercepted a telephone conversation of the terrorists, which confirms the fact that the detained military personnel from Russia Starkov had to provide the illegal militant group "DPR" with weapons, including from the Russian Federation.



## REPRESSIONS OF "DONETSK PEOPLE REPUBLIC".

During the occupation of the Donetsk region illegal organization "DPR" organized several press - conferences in which the representatives of Ukrainian public institutions allegedly voluntarily announced about their decision to work with the separatists. And almost every time the Ukrainian side denied this information. In most cases, people made their statements under the pressure of the armed militants, often after lengthy tortures.

**Vitaliy Balbek and Oleksiy Kobzar stayed 19 days in captivity.**

According to the regional police, the day after the arrest militants of "DPR" took two traffic inspectors and their friend Herman Salnikov to Yelenivka with the purpose of shooting.

First they shot at Hermann, wounded him, then one of the militants approached him and finished him with the sword in the back. Later Herman body was recognized by his father in one of the morgues. Then they took the traffic policemen back to Donetsk.

Now the traffic policemen are outside of the occupied territory.

**Another example: the separatist media distributed the information that the chief deputy of the regional department of the Ministry of Justice Serhiy Kucheruk took the side of the "DPR".**

Kucheruk was on vacation and went to his wife and daughter. Kucheruk went there and was in the basement, then there were threats to his wife and daughter, and then he came out and announced that he would work with "DPR". *And this is not the last example.*



## RUSSIAN "HUMANITARIAN AID" POISON THE CHILDREN IN THE DONBASS.

In the Donbass they recorded frequent cases of poisoning of children because of the poor quality of food from the so-called Russian "humanitarian aid". This was stated by the representative of the Presidential Administration of Ukraine for ATO Andriy Lysenko.

They announce an increase of poisoning cases of local people, including children, as a result of the eating of dishes, which were cooked from the products of poor quality and with expired using data. These products arrive in the occupied territories of Eastern Ukraine as a so-called "humanitarian aid" from Russia.



## SECURITY SERVICE OF UKRAINE SHOWED STOLEN IN THE OCCUPIED DONBASS CHURCH CROSSES.

Supporters of the "DPR" and "LPR" come to pillage the churches: they extracted from the churches gold and other valuables, and then sell it.

The terrorists continue to pillage. First there were apartments and cars of locals. Now they do it with the churches, carrying out everything as they think it can be sold then. They try to take the looted things out of the uncontrolled by Ukraine territories, so they can sell it all together with their accomplices.

In the Luhansk region on July 29 Security Service of Ukraine together with the armed military forces and border guards eliminated a smuggling channel through the dividing line of a large batch of items made of precious metals.

On the railway line near the station Kondrashevskya (Stanichno Luhansk district) Security service of Ukraine and military men stopped a trade train. During the examination of the locomotive they revealed five shopping bags with jewelry and gift items, church items.

The weight of these things is tens of kilograms. The terrorists tried illegally to export from the occupied territories gold and silver dishes, icons, crosses, Panagia - products of one of the famous manufacturer of jewelry products, remaining on the territory, controlled by the separatists of "LPR".

They opened the criminal proceedings under Art. 258-5 of the Criminal Code of Ukraine - the financing of terrorism. They continue the investigative and operational measures to establish all the details of the offense
